Called to Discern

He (God) is greatly honored by the time we take to weigh with mature deliberation matters having to do with his service, as are all those with which we deal. St. Vincent de Paul



Since the early days of our Society, it has been held that being a Vincentian is a vocational call. Through our vocation, we are called to serve Christ through service to the poor. Our call is not for everyone nor is it always easy. It is a journey into holiness that takes an open heart, a listening ear, and a willingness to learn and grow.

St. Vincent de Paul and the ministries and programs he founded helped many of the poor and needy of his day, but they did not help everyone. They could not physically help everyone that needed assistance, and neither can we. So how do we decide who and how to help the poor?

The Vincentian charism is centered around making decisions through a discernment process rather than a more traditional style of business decision making. By definition discernment is a wise or enlightened way of evaluation that includes seeing things in a more sensitive and perceptive way where unspoken and unseen factors become visible. For us, our goal is to try to see each neighbor as God sees them. To take the time to sit and reflect on

their story, their request, and God's plan for them and for us.

Looking at the bare facts of a situation without trying to understand the neighbor, their story and their options, often leads us to be harsh, rigid and judgmental. Being rigid and judgmental can lead us to inaccurate conclusions and to premature decisions based primarily on our own opinions, impressions, and preconceived ideas about situations and other people. We have a tendency to see their life and situations through our own experiences, opportunities and choices not theirs.

Discernment does not require us to say yes to every request. Sometimes the best way to help a neighbor is to say no, maybe, or can we work on resolving this issue together? Discernment takes time, thought and prayer. Discernment leads to compassion and creativity. Discernment considers conference guidelines, financial factors, and outcomes but it includes so much more than those factors. Discernment is not an *all or nothing* process but one that is more organic, flexible and Christ-centered.

As Vincentians, we are called to discern and to act with compassion and empathy. We need to realize that the majority of people we encounter are doing the very best they can with what they have available to them and that some people will never be capable of being sustainable. Some neighbors come to us again and again not because they are using the system but because they simply have no other viable options.

We are called to pray, to call upon the Holy Spirit, and to discern God's will concerning our responses to each neighbor's request. We must continually ask the Lord to show us how we can best serve each person we encounter. The Gospel tells us that whatever we do for the least of our brothers, we do for Jesus but it goes on to warn us that what we do not do for the least of our brothers, we do not do for Christ.

We should never be in such a rush that we say no when there is a more God centered way to respond. If we are to err, let us pray that we always err on the side of generosity. May we strive to make decisions with mature and Christ-centered deliberation.

DISCERN, NOT TO DECIDE

In the Society of St Vincent de Paul, “*all decisions are made by consensus after the necessary prayer, reflection and consultation.*” [\[Rule, Part I, 3.10\]](#) In other words, we don’t simply vote the minority “off the island,” but instead ensure that every voice is heard as we seek to arrive

at a solution that everyone can support. The process of prayer, reflection, and consultation that we follow to arrive at consensus is discernment.

Discernment, in turn, is not simply a decision-making process, in which we tally up the plusses and minuses, or offer arguments for our positions. It is instead a search for truth, and that truth, for us, is always the will of God. To truly discern requires that each of us let go of our attachment to our own ideas, keeping our minds and hearts open not only to the ideas of others, but to the idea that our purpose is not to choose from among competing alternatives, but to find the one truth that is God’s will.

Our first Rule explained the importance of self-denial in this process, saying that “*The man who is in love with his own ideas, will disdain the opinion of others... We should, therefore, willingly acquiesce in the judgment of others, and should not feel annoyed if our own propositions be not accepted by them. Our mutual good will should proceed from the heart and should be without bounds.*” [\[Rule, Intro, 1835\]](#)

These words echo St. Vincent de Paul, who said that we should “*deny ourselves totally for love of God, to bring our judgment into harmony with that of our neighbor... and conforming to God’s judgment of things!*” [\[CCD XII:175\]](#) For Saint Vincent de Paul, the will of God was always the center of holiness, and always the guiding light for his works and his plans.

Discernment is not a contest to determine whose will is strongest, but instead is always a seeking of God’s will to guide us, whether discerning our individual pathway, discerning the best way to help a neighbor, or discerning a plan for new special works. If we truly believe that God called us to this Vincentian vocation, we must also believe that the God who called us here is here; that he is within and among us; that each of us individually and all of us as a group were called here by God; and that it is His voice and His will we are called to continue to serve. He makes His will known to us through Holy Scripture, through the Rule and traditions of the Society, and through the people and events in our lives. To deny ourselves in this process doesn’t mean refusing to say what we think. It means offering our reasons, but not our judgment. It means having the humility to recognize that we do not know all the answers, and being willing to accept God’s will as it is revealed to us, even – and especially – when it contradicts our own preconceived notions.

In other words, if we truly wish to hear His voice, we must first lower our own.

Disaster Appeals

“When disasters, war or major accidents occur, the Society launches emergency initiatives on the spot and provides funds for the local Society to help victims.”

Rule Part I: 4.2

There are two types of assistance when discussing disasters: domestic disaster assistance and international disaster assistance. Hurricanes, tornadoes, floods, tsunamis, and fire are all causes for a disaster. Although SVDP is usually not a first responder, SVDP is on the ground, providing comfort, support, and financial assistance.

In the Rule Part III: Statute 26 we are reminded:

“However, no matter how worthy the cause, funds shall not be diverted in the form of donations or contributions to other organizations or charities, except, occasionally, for other branches of the Vincentian Family.”

When a family loses a home, it is a disaster for that family and their needs will be addressed at the conference level. When a disaster is declared at the national or international level a significant number of people are affected.

A request for financial assistance is issued through either our National Council's Disaster Fund or through our International Council General's offices. Assistance is sent to conferences serving in the area of the disaster. This assistance should be sent to our National Office and identified as either for National Disaster or International Disaster. There is no need to be more specific than that. Please do not list a specific disaster as then the money is restricted for that one particular area. There must be active conferences that can provide the assistance.

When Ukraine was attacked, several conferences wanted to contribute disaster funds. However, there were no conferences in that country still operating and many people were fleeing to other countries. If the money was labeled “For Ukraine” it could not be used in the countries with conferences receiving the refugees. If it was identified as “International Disaster,” it would first be sent to our National Office and then be forwarded to the International Office which maintains records and communications with our brother and sister conferences outside of the United States and where emergency funds are needed.

FROM THE DESK OF CONFERENCE RESOURCE COMMITTEE

Standards of Affiliation are minimum standards that should be included and followed in every conference set of guidelines. Conference operational guidelines should not contradict this minimum standard set.

Membership

Participation in the works of the society is open to all, with no exclusions based on gender, age, race, ethnic background, or sexuality. Part III of the Rule states that only Catholics may be “Full” members or officers. Diversity within Conferences is healthy. Youth (minors) should be accompanied by a parent or other designated adult. Meetings should be planned to include people who work. New members should be invited regularly and welcomed.

Standing Committees

Conferences may have standing committees, i.e. Store committee, Pantry Committee, Systemic Change Committee. All committees should be open to any member willing to provide consistent service.

Training

TRAINING IS REQUIRED in order to live the Vincentian vocation fully and to assure quality in services. For day-to-day work the training takes place at the Conference level. Anyone wishing to become a full member of the conference, with voting privileges, are obligated to attend the 4 session Ozanam Formation Experience (OFE). All Conference officers must have taken OFE or agree to attend OFE within one year of taking office. A refresher of OFE is suggested for every three or four years.

Safe Environment Training

All Members of the Society (and volunteers with regular commitments) must comply with the training and background check requirements of the Diocese of Phoenix.

QUESTIONS & ANSWERS

Question: Can Associate members go on home visits?

Answer: Associate members can go on home visits if the Conference has confidence in their knowledge of the Society, their understanding of the purpose and format of home visits, and in their judgment. Associate members should not go along on home visits just to fulfill the two Vincentian requirement. They must be able to participate fully in the encounter with the individual and/or families being visited.

Question: Can membership in the Society be terminated by a Conference president?

Answer: No. A member is considered separated from the Society under the following Conditions:

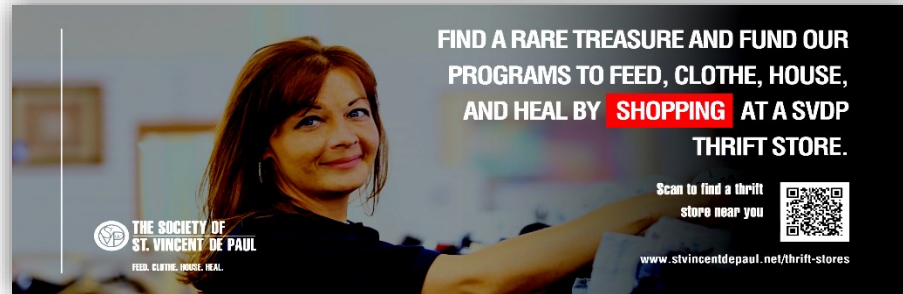
- Voluntary resignation or cessation of effective membership (e.g., protracted unexcused absence from Conference meetings).
- *Enforced resignation. Implemented only for grave reasons and for the common good of the Society. Approval for such action must first be obtained from the National President. (Rule, Pt. II, Statute 17)*
